**STATEMENT OF WARRANTY**

HLT Limited hereafter known as The Company warrants to the original purchaser of its Eagle products that the products manufactured by it will be free from defects in materials and workmanship for one (1) year beginning on the date of purchase. Eagle Trailers manufactured by HLT Limited are also covered by an extended warranty on the trailer frame. See (5) five or (1) one year Frame Limited Warranty. This warranty is extended to the original purchaser only and does not apply to used trailers or trailers used for commercial purposes. This warranty also does not apply to trailers that have been altered, or subjected to misuse, overloading, or negligence. The Company does not recommend painted trailers for salt water use, it is impossible to warrant the finish or structure on painted trailers used in a salt water environment. For this use we manufacture and recommend our hot dip galvanized Series trailer.

Equipment manufactured by others and incorporated by The Company into its products are not warranted by The Company but are sold exclusively under any warranty of the manufacturer of the incorporated parts and only to the extent such other warranty is enforceable and transferable by The Company.

In the event the original purchaser returns a product to our 1419 11th St. N., Humboldt, IA 50548 factory, freight prepaid, within one (1) year from the date of purchase and The Company determines that the product was defective when delivered to the original purchaser and immediate notification of the defect was given by the original purchaser to The Company at the above address, then The Company will, at its option, either repair or replace the defective trailer. Immediately upon discovering a potential defect the original purchaser should send written notification of the potential defect to The Company describing the potential defect stating the date and place of purchase and providing The Company with an address and telephone number where the original purchaser can be contacted. To insure receipt, such notification shall be sent to The Company by certified mail, return receipt requested.

Patriot Series, Special Edition, and Premier Edition Trailers manufactured by HLT Limited carry an extended limited warranty on the frame and all components welded to the frame at the time of manufacture. The Company warrants to the original purchaser of its products that the frame will be free from defects in materials and workmanship for five (5) years beginning at the date of purchase. This warranty is extended to the original purchaser only and does not apply to used trailers or trailers used for commercial purposes. This warranty also does not apply to trailers that have been altered, or subject to misuse, overloading or negligence.

Hot dip galvanized Series Eagle Trailers manufactured by HLT Limited carry a limited warranty on the frame and all components welded to the frame at the time of manufacture. The Company warrants to the original purchaser of its products that the frame will be free from defects in materials and workmanship for one (1) year beginning at the date of purchase. This warranty does not cover all aluminum components against pitting or other finish problems. Due to the highly corrosive conditions that a trailer is exposed to, rust formation is not covered. This warranty is extended to the original purchaser only and does not apply to used trailers, adjustable trailers or trailers used for commercial purposes. This warranty also does not apply to trailers that have been altered, or subjected to misuse, overloading or negligence.

The Frame warranty covers the structural integrity of the frame and the components welded to it (not including the couplers or actuators.) It does not include the paint finish, galvanized finish, wiring system, brake shoes, bearings, plated components, painted components, or any other components nor items made by others and covered by their own warranties, either longer or shorter in duration. Except as specifically stated in this Limited Warranty. The Company makes no other warranties, expressed or implied, and all implied warranties INCLUDING THE WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE ARE LIMITED TO ONE (1) YEAR from the date of purchase and THEREAFTER ALL SUCH WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE ARE DISCLAIMED AND EXCLUDED. The liability of The Company under this Limited Warranty is limited to repair or replacement of the defective part; all claims for incidental, consequential or resulting damages are specifically excluded. Some states do not allow the exclusion of limitation or incidental or consequential damages, and some states do not allow limitations on how long an implied warranty lasts, so the above limitations or exclusions may not apply to you.

The return of the Owner's Registration Card by the original purchaser is a condition precedent to this Limited Warranty. Failure to return the Owner's Warranty Card within thirty (30) days after the date of purchase may void the Limited Warranty provided herein.

This One/Five Year Limited Warranty is the exclusive warranty of The Company. The SALES PERSONNEL or other employees of The Company or dealers are NOT AUTHORIZED TO MAKE WARRANTIES concerning The Company products, and no oral statements shall constitute a warranty by HLT Limited. This limited warranty gives you specific rights, and you may also have other rights which vary from state to state.
